## *Commitment*

D & M Plant Hire Management is committed to ensuring that in providing dry and wet hire of plant, the risks to Health and Safety or impacts on the Environment are minimised in so far as it is practicable. - As a minimum, comply with any applicable Occupational Health, Safety and Environmental legislation, and any relevant statutory requirements;
- Review and analyse relevant data and information to make informed decisions relating to QSE requirements;
- Strive for continuous improvement in our QSE performance through the identification and implementation of strategic QSE objectives and targets;
- Ensure all incidents and non-conformances are reported and recorded and root causes identified to ensure corrective actions can be implemented to ensure continuous improvement to QSE outcomes; and
- Allocate the necessary human and financial resources to meet the commitments of this Policy.
